NOTIFICATION OF APPLICATION SAN DIEGO GAS & ELECTRIC COMPANY'S REQUEST TO INCREASE ELECTRIC RATES NO. A.21-08-010

WHY AM I RECEIVING THIS NOTICE?

On August 13, 2021, San Diego Gas & Electric Company (SDG&E®) filed the 2022 Electric Sales Forecast Application (A.21-08-010) with the California Public Utilities Commission (CPUC) for approval to increase electric rates.

If adopted, new rates are expected to begin on January 1, 2022.

WHY IS SDG&E REQUESTING THIS RATE INCREASE?

Electric sales forecasts provide details on how much electricity SDG&E customers are expected to use for the upcoming year. Accurately forecasting the amount of electricity that will be used is important to help ensure SDG&E does not overcharge or undercharge for electric service.

HOW DOES THIS IMPACT MY ELECTRIC RATES?

If SDG&E's rate request is approved by the CPUC, the 2022 Electric Sales Forecast will be used to update electric rates to more accurately reflect the cost of electric service for various customer classes and associated rate options. Although the application proposes no change to SDG&E's overall revenue, adoption of the 2022 Sales Forecast may result in rate increases for certain electric customers. In 2022, SDG&E's overall electric sales (16,719 GWh) are expected to decline by 8% when compared to currently adopted electric sales (18,210 GWh). Due to the decline in electric sales, SDG&E is requesting to increase rates to recover the previously approved revenue.

As discussed further below, the present application is seeking a rate increase, but the requested increase will be one factor among many that will determine actual rates at the time of implementation.

The projected rate increase described in the application and this notice are illustrative and are likely to change prior to inclusion in SDG&E's 2022 rates.

The illustrative rate changes shown in columns B and C reflect what is requested in this application. Columns D and E are provided for informational purposes to illustrate the combined impact of this and another application to decrease rates (A.21-04-010). SDG&E is seeking for both requests to be implemented simultaneously in 2022.

SDG&E's request will not have any impact on gas rates.

HOW DOES THE REST OF THE PROCESS WORK?

This application will be assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt SDG&E's application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding are currently reviewing SDG&E's application, including the Public Advocates Office, which is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels.
