

Schedule EV-TOU-5-P - CARE - DOMESTIC TIME-OF-USE FOR HOUSEHOLDS WITH ELECTRIC VEHICLES provides domestic residential service for customers who own qualifying electric vehicles. Effective 8/1/2026

The following are the CARE rates associated with service under Schedule EV-TOU-5. This schedule is SDG&E's residential rate for customers with an electric car or use electricity to run a natural gas home fueling pump who also choose to manage their electric costs by reducing their use when an event is called. The car must be registered with the California Department of Motor Vehicles.

In addition, they include the line-item discount and exemptions from the CARE surcharge, DWR Bond Charge, and Wildfire Nonbypassable Charge as identified in Schedule E-CARE. The UDC rate-by-rate components presented are associated with service under Schedule EV-TOU-5 - CARE as presented in the utility's tariff book. 2) Unbundled customers are those who take generation from other providers, such as Direct Access (DA) or Community Choice Aggregation (CCA). Unbundled customers do not pay SDG&E's commodity rates. The Total Energy Charge for an unbundled customer includes UDC, WF-NBC, DWR-BC and Power Charge Indifference Adjustment (PCIA) rates.
