# **Dynamic Export Rate Pilot**

## Earn bill credits with Dynamic Export

The Dynamic Export Rate Pilot will allow business customers with electric vehicles, battery storage, backup and other generators to manage their energy use and budgets by purchasing electricity when pricing is lower and selling excess generation back to SDG&E® when pricing is higher. This innovative energy management program can provide savings for your business while enhancing grid reliability.

## Energy management to support the grid and your budget

Electricity used (imported) by your business is priced according to your pricing plan (EV-HP, AL-TOU or TOU-A). Bill credits for excess electricity sent back to the grid (exported) from your battery or generator are based on the day-ahead hourly price of electricity set by the California Independent System Operator (CAISO) plus a Generation Capacity Component (GCC) added by SDG&E on event hours. The day-ahead-prices will be published on sdge.com to allow you to plan and adjust energy management.

## Who can participate?

The Dynamic Export Rate Pilot has been designed specifically for SDG&E generation and delivery customers who do not have solar and are currently on the EV-HP, AL-TOU, or TOU-A pricing plan. To export energy back to the grid through SDG&E's distribution system, participants must also have an approved Rule 21 interconnection agreement on file with SDG&E.\*

## How do I enroll?



#### STEP 1

Participants must have an active Electric Rule 21 interconnection agreement with SDG&E, which may include fees and other upfront costs. Learn more and apply online at **sdge.com/Rule21**.



#### STEP 2

After your interconnection agreement is approved, enroll in the Dynamic Export Rate Pilot by calling the Business Customer Care Center at 1-800-366-7343.



#### STEP 3

The Pilot begins on January 1, 2025. Enroll now and your account will automatically transition to the Dynamic Export Rate for your first bill in 2025.

\* Pilot participants must receive both electric generation and delivery service from SDG&E on the EV-HP, AL-TOU or TOU-A pricing plan and have a completed Rule 21 interconnection agreement with SDG&E. The pilot is not available to solar (NEM or Solar Billing Plan), Community Choice Aggregation (CCA) or Direct Access (DA) customers, as well as customers on legacy rates, conjunctive billing, or who are currently enrolled in any Demand Response programs. Actual savings may vary and will depend on various factors, including geographic location, weather conditions, equipment installed, usage rates and similar factors.
