## What are the program requirements?

1. Premises has not had an audit within the last 3 years.
2. Your business has a monthly on-peak demand of 100 kilowatts (kW) or greater for three consecutive months (if multiple meters are present at one premises for one customer, meter usage can be aggregated by premise and customer to meet demand threshold).
3. The business is currently being billed on a commercial, industrial or agricultural Time-of-Use rate by SDG&E®.
4. Must have occupied the premises for a minimum of 6 months.

All businesses that qualify will have a High Level Audit performed.

## Category 1 - High Level Audit

Walk-through your business with an engineer and/or contractor and receive:

- Detailed list of all the energy consuming equipment located on premises

- Recommendations on best energy-saving measures and high-level estimates of measure costs, energy savings, and payback periods

## Category 2 - Detailed Investment Grade Audit

The selected measures/opportunities, by the customer, will have full calculations developed. These detailed calculations, which include install costs, incentives and payback values, will then be reviewed with the customer in order for the customer to make a decision to proceed.

- Produces a report and presentation of recommended and actionable options based on Customer requests and requirements
- Businesses that plan to implement the Category 1 recommended measures within 1 year of the audit can request a Category 2 audit for more detailed calculations of those targeted measures
