

Schedule DT-RV - SUBMETERED SERVICE - RECREATIONAL VEHICLE PARKS AND RESIDENTIAL MARINAS Effective 10/1/2024

The following are the CARE/Medical Baseline rates associated with service under Schedule DT-RV. Schedule DT-RV provides domestic electric service to qualifying residents of recreational vehicle (RV) parks and residential marinas through one meter on a single premises and submetered to all RV park and residential marina tenants.

Notes:

- The total rates presented reflect the UDC rates associated with service under Schedule DT-RV - CARE and the generation rates associated with Schedule EECC. In addition, they include the line-item discount and exemptions from the CARE surcharge, DWR Bond Charge, Wildfire Nonbypassable Charge, and VGI as identified in Schedule E-CARE. The UDC rate-by-rate components presented are associated with service under Schedule DT-RV - CARE as presented in the utility's tariff book.
- Unbundled customers are those who take generation from other providers, such as Direct Access (DA) or Community Choice Aggregation (CCA). Unbundled customers do not pay SDG&E's commodity rates. The Total Energy Charge for an unbundled customer includes UDC, WF-NBC, DWR-BC and Power Charge Indifference Adjustment (PCIA) rates. PCIA rates by vintage are included below. Please see Schedules DA-CRS or CCA-CRS for more information regarding PCIA rates.
