SDG&E Response 01:

Subject to the objection stated in ORA-SDGE-161-MRK Q5 asked "where in this document ["MDR Section Q9 ferc_sdge_annual_report_2016.pdf"] can the total amount of ITCC, the total electric amount of ITCC, and the total gas amount of ITCC reported in 2016 be found." SDG&E responded that the amount cannot be found in the "MDR Section Q9 ferc_sdge_annual_report_2016.pdf." The gas amount is combined with other line items and therefore cannot be separately identified in the FERC SDGE annual report.

The electric and gas ITCC amounts are in the accounting records within the accounting software.
